1. Catholic Cemetery of Mobile, Mobile, Alabama

A. Hours of Operation

The gates to Catholic Cemetery of Mobile are open from 8:00 a.m. to 4:00 p.m., 7 days a week. There is no office on the cemetery grounds. The office for the Catholic Cemetery of Mobile, and its owner, Catholic Cemeteries, Inc., is located at 356 Government Street, Mobile, Alabama. The office hours are 8:30 a.m. to 4:30 p.m., Monday through Friday.

C. Interment and Disinterment

1. Catholic Cemeteries, Inc. has an exclusive contract for opening and closing graves in the Catholic Cemetery of Mobile with Gulf Wilbert Vault Company, Inc. No other company or individual is authorized to open or close a grave in the Catholic Cemetery of Mobile without the written consent of Catholic Cemeteries, Inc.

D. Memorials, Foundations and Installation

1. Unit 1 of Catholic Cemetery of Mobile is the Cemetery opened in 1848 and contains Sections I through XLVIII. Most types of memorials are allowed in Unit 1, including slabs or ledgers, but all memorials and the foundations for memorials must be pre-approved by the Director of Catholic Cemetery of Mobile.
2. Unit 2 of Catholic Cemetery of Mobile is the Cemetery opened in 1863 and contains Sections A through N. Most types of memorials are allowed in Unit 2, including slabs or ledgers, but all memorials and the foundations for memorials must be pre-approved by the Director of Catholic Cemetery of Mobile.
3. Unit 3 of Catholic Cemetery of Mobile is the Cemetery opened in 1948 contains Sections 1 through 12 and the Holy Sepulcher Mausoleum & Columbarium. No slab or ledger memorials are allowed in Unit 3. Memorialization allowed is as follows for the Unit 3 Sections:
 - A. Unit 3, Sections 1, 5, 6, and 6A: One upright monument is permitted on the monument line at the head of the lot on 6 or more grave spaces, containing 160 square feet or more. The maximum base length shall be 4.5' for a half lot or 6' for a full lot. Standard 2' x 1' x 4" or 3' x 1' x 4" lawn-level granite, marble or

bronze markers on granite bases are allowed for individual grave spaces.

- B. Unit 3, Section 2: Individual markers for the names memorialized on the Cenotaph in the St. Francis of Assisi Garden are not allowed. Individual markers are not allowed in the Infant lots. For the other lots in Unit 3, Section 2, one upright monument is permitted on the monument line at the head of the lot on 6 or more grave spaces, containing 160 square feet or more. The maximum base length shall be 4.5' for a half lot or 6' for a full lot. Standard 2' x 1' x 4" or 3' x 1' x 4" lawn-level granite, marble or bronze markers on granite bases are allowed for individual grave spaces.
- C. Unit 3, Sections 3, 7, 7A, 8, 9 and 12: One upright monument is permitted on the monument line at the head of the lot(s) on 4 or more grave spaces, containing 200 square feet or more. The maximum base length to be 5' for a half lot or 6' for a full lot. Standard 2' x 1' x 4" or 3' x 1' x 4" lawn-level granite, marble or bronze markers on granite bases are allowed for individual grave spaces.
- D. Unit 3, Section 10, Blocks 1 through 8: No upright monuments are allowed. Standard 2' x 1' x 4" or 3' x 1' x 4" lawn-level granite, marble or bronze markers on granite bases are allowed for individual grave spaces. Standard 3' x 1' x 4" lawn-level granite, marble or bronze markers on granite bases are allowed on a two-space lot.
- E. Holy Sepulcher Mausoleum: Only lettering ordered by and placed by the cemetery staff or its contractors shall memorialize the crypt fronts in the Holy Sepulcher Mausoleum. No other memorialization shall be allowed and any other memorialization added to crypt fronts shall be removed by the cemetery staff without notice to the Certificate Holders.
- F. Holy Sepulcher Columbarium: Only lettering ordered by and placed by the cemetery staff or its contractors shall memorialize the niche fronts in the Holy Sepulcher Columbarium. No other memorialization shall be allowed and any other memorialization added to the niche fronts shall be removed by the cemetery staff without notice to the Certificate Holders.

- G. Memorial placement applications and memorial placement fees shall be submitted to the office of Catholic Cemetery of Mobile at least three (3) days prior to memorial placement. Cemetery personnel or cemetery contractors shall identify the location for memorial placement with a survey flag containing the deceased's name, lot number, and space number. No one else is authorized to specify the location for memorial placement in the cemetery.
